ALSO EXCEPTING THEREFROM that portion lying within the right of way of Altamont Drive.

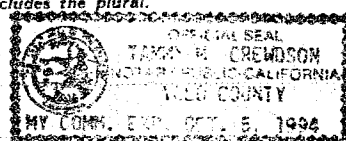
