LINE OF CREDIT MORTGAGE. (a) This Deed of Trust is a LINE OF CREDIT MORTGAGE. (b) The maximum amount to be edvanced pursuant to the credit agreement is \$5,001.00. (c) The term of the credit agreement commences on the date of this Deed of Trust and ends on or after July 10, 1997.

THIS DEED OF TRUST IS DATED JULY 10, 1992, among Pence Loving Trust, Stenley J. Pence and Beverly A. Pence, husband & wife, whose address is P.O. Fox 165, Malin, OR 97632 (referred to below as "Grantor"); First interstate Bank of Oregon, N.A., whose address is 206 East Front St., P.O. Box 428, Merrill, OR 97633 (referred to below sometimes as "Lendhr" and sometimes as "Beneficiary"); and Mountain Title Co., whose address is 222 S. 6th St. Klamath Falls, OR 97601 (referred to below as "Trustee").

CONVEYANCE AND GRANT. For value ble consideration, Grantor conveys to Trustee for the benefit of Lender as Beneficiary all of Grantor's right, title, and interest in and to any Leass the following described real property, together with all existing or subsequently erected or affixed buildings, improvements and following; all easements rights of way, and appartenences; all water, water rights and ditch rights (including stock in utilities with ditch or krigation rights); and all other rights, invalides, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar masters, located in Klansith County, State of Oregon (the "Heal Property"):

Lots 1 and 2 in Block I), RAILROAD ADDITION TO THE CITY OF MALIN and Lots 3, 4 and 5, Block D, RAILROAD ADDITION TO THE CITY OF MALIN.

The Real Property or its address is commonly known as 2642 Front St., Malin, OR ..

Grantor presently assigns to Lender (also known as Beneficiary in this Deed of Trust) all of Grantor's right, title, and interest in and to all present and future leases of the Property and all Ren's from the Property. In addition, Grantor grants Lender a Uniform Commercial Code security interest in the Rents and the Personal Property defined below.

(b) Grantor does not meet the repayment terms of the credit line account. Other Remedies. Trustee or Lender shall have any other light or remedy provided in this Deed of Trust or the Credit Agreement or by law.

Sale of the Property. To the extent permitted by applicable law, Grantor hereby waives any and all rights to have the Property marshalled. In exercising its rights and remedies, the Trustee or Lender shall be free to sell all or any part of the Property together or separately, in one sale or by separate sales. Lender shall be entitled to bid at any public sale on all or any portion of the Property.

Attorneys' Fees; Expenses.
