

TERMINATION OF EASEMENT

THIS TERMINATION OF EASEMENT, dated this 2nd day of July, 1992, by the UNITED STATES OF AMERICA, acting by and through the Forest Service, Department of Agriculture,

WHEREAS, Klamath County granted to the United States of America an easement for a telephone line, dated March 2, 1932, and recorded on March 3, 1932, as Instrument No. 802 in Book 97, at page 98, County of Klamath, State of Oregon, over and across the following described premises:

T. 36 S., R. 15 E., W.M.
sec. 21, N1/2SW1/4

which easement contained the following provisions:

"This grant shall be effective only so long as said easement shall be actually used for any of the purposes above specified, but all rights hereunder shall revert to the owner of the land as soon as the said use thereof shall be abandoned and discontinued."

and

WHEREAS, the undersigned has determined that the United States of America has no further need for said easement.

NOW THEREFORE, this TERMINATION OF EASEMENT is executed for the purpose of showing that it has been determined that the United States of America has no further need for the easement and that the easement pursuant to its provisions has ceased and terminated and is hereby cancelled.

IN WITNESS WHEREOF, the United States of America, by the Director of Lands, Pacific Northwest Region, Forest Service, pursuant to the delegation of authority dated August 22, 1984 (49 FR 34283), has executed this TERMINATION OF EASEMENT on the day and year first above written.

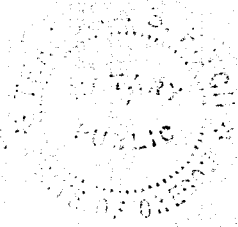
