FOR THE PURPOSE OF SICURING PERFORMANCE of each agreement of grantor herein contained and payment of the sum of (\$ 3,369.00 ). After July 1, 1993 this note shall be reduced at a rate of 20% of the total each year over the next five (5) years and will be deemed fully satisfied July 1, 1998.
