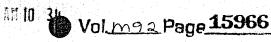


TRUST DEED

WITTNESSETH:

Grantor irrevocably grants, bargains, sells and conveys to truster in trust, with power of sale, the property in Klamath County, Oregon, described as:

A portion of Lots 7 and 8, Block 51, NICHOLS ADDITION to the City of Klamath Falls, Oregon, and more particularly described as follows:

Beginning at a point on the Northeasterly line of said Lot 8, said point being Northwesterly along the Northeasterly boundary of said Lot 8 a distance of 56.5 feet from the most Easterly corner of said Lot 8; thence

Southwesterly at right angles to said Northeasterly boundary a distance of 104.24 feet; thence

Northwesterly and parallel to 10th Street a distance of 63.5 feet to the Southeasterly boundary line of Jefferson Street; thence
