The SE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 30, Township 25 South, Range 8 East, W.M., Klamath County, Oregon, Tax Lot 2100.

The easement is as follows: A strip of land 10 (ten) feet in width and 2000 (two thousand) feet in length, within that certain private roadway known as Forest Service Road No. 5825, as placed, and being a portion of the above described property.

Telephone cable will be placed at a depth of 30". Grantor is not liable for damage to cable if it is less than 30" measured from the bottom of the ditch.

The rights, conditions and provisions of this easement shall inure to the benefit of and be binding upon the heirs, executors, administrators, successors and assigns of the respective parties hereto.

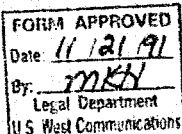
