A portion of the SE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 28, Township 40 South, Range 11 East, W.M., Tax Lot 800, Klamath County, Oregon.

The easement is as follows: A strip of land 10 (ten) feet in width and 1700 (one thousand seven hundred) feet in length, along the Southeastern side of the private roadway known as Pope Road, emaeament is for one time placement of aerial cable on the P.P.&L. poles, as placed, and being a portion of the above described property.

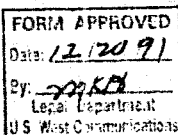
The Grantor reserves the right to occupy, use and cultivate said Easement for all purposes not inconsistent with, nor interfering with the rights herein granted.
