DESCRIPTION FOR Account #3909-8BC-500

A tract of land situated in the SW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 8, Township 39 South Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at a point on the Southeasterly right of way line of the Weed-Klamath Falls Highway, which point is North 44°50 $\frac{1}{2}$ ' East a distance of 138 feet from the intersection of the Southeasterly line of said highway with the Westerly line of Section 8, and the true point of beginning; thence continuing North 44°50 $\frac{1}{2}$ ' East along said Southeasterly line a distance of 300 feet; thence North 45°09 $\frac{1}{2}$ ' West a distance of 20 feet; thence North 44°50 $\frac{1}{2}$ ' East along the aforementioned highway right of way line a distance of 50 feet; thence South 45°09 $\frac{1}{2}$ ' East at right angles a distance of 320 feet; thence South 44°09 $\frac{1}{2}$ ' West parallel to said highway line a distance of 350 feet; thence North 45°09 $\frac{1}{2}$ ' West 300 feet to the point of beginning.
