SUBJECT TO Trust Deed recorded in Volume M78, page 27653, Microfilm Records of Klamath County, Oregon in favor of Klamath First Federal Savings & Loan, which Grantee agrees to assume and pay in full.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 44,357.00

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.

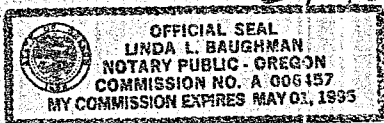
