 pertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to-wit:

All That portion of the SE<sup>1/4</sup>NW<sup>1/4</sup> of Section 14, Township 40 South, Range  
 9 East of the Willamette Meridian, lying Easterly of the U. S. B. R. 3-C  
 Drain, Klamath County, Oregon.

Subject to reservations, restrictions, rights of way of record and those  
 apparent upon the land; Liens and Assessments of Klamath Project and  
 Klamath Irrigation District and Klamath Basin Improvement District;
