MEMORANDUM OF RESTRUCTURE AGREEMENT

The undersigned ("Borrower"), whose address is P.O. Box 371, Chiloquin, Oregon 97624, and Farm Credit Bank of Spokane, successor by merger to The Federal Land Bank of Spokane, whose address is West 601 First Avenue, Spokane, Washington 99220-4005 ("Lender") entered into that certain Restructure Agreement signed on the 24<sup>th</sup> day of JUNE, 1992 ("Agreement") to amend the Note dated October 3, 1978, and any amendments thereto (the "Original Note") and Mortgage dated October 3, 1978, recorded on October 12, 1978, as Instrument No. 56620 in Book M78, Page 22907, records of Klamath County, State of Oregon, and any amendments thereto (the "Loan Documents"), encumbering the real and/or personal property described therein, reference to which is made for the terms and the description of property. This Memorandum is an abstract of the Agreement. The Agreement provides for the indexing and adjustment of the interest rate, payment terms or balance due on the obligation evidenced by the Original Note and Loan Documents. The Agreement extends the final maturity date to May 1, 2004. The Original Note as amended by the Agreement is hereinafter referenced as the "Note." The interest rate, payment terms or balance due under the Note and Loan Documents may be indexed, adjusted, renewed or renegotiated.

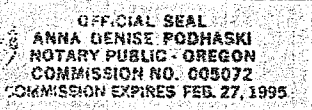

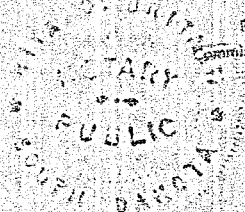

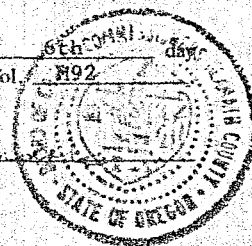
