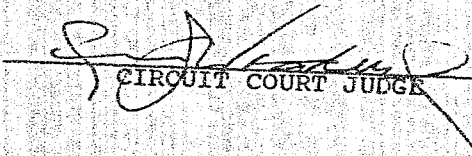
1 personal property within her possession and control, free and clear
