KNOW ALL MEN BY THESE PRESENTS, That MILDRED THOMAS

hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Mildred Thomas, Trustee of THE THOMAS LIVING TRUST hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

## RERECORDED TO CORRECT VESTING

A parcel of land situated in the SE  $\frac{1}{4}$ -SW  $\frac{1}{4}$  Sec. 1, T.39 S., R. 9 E.W.M. in Klamath County, Oregon, and being more particularly described as follows:

Beginning at an iron pin on the Easterly right-of-way line of Patterson Street, as the same is presently located and constructed, from which an iron pin marking the Northwest corner of the SE  $\frac{1}{4}$ -SW  $\frac{1}{4}$  of Section 1, T. 39, S., R.9 E.W.M. bears S 89°06' W. 30 feet distant; thence S 0 54' E along the said Easterly right-of-way line of Patterson Street 1000 feet to an iron pin on the Northerly right-of-way line of Maryland Street; thence N 89°06' E along the said Northerly right-of-way line of Maryland Street 420 feet to an iron pin and the true point of beginning of this description; thence N 0 54' W 96.7 feet to a point; thence N 89°06' E 100 feet to a point; thence S 0 54' W 96.7 feet to a point; thence S 89°06' W 100 feet more or less to the true point of beginning.
