

## EXHIBIT "A" LEGAL DESCRIPTION

A portion of Lot 71, FAIR ACRES SUBDIVISION NO. 1, being situated in the NE1/4 SE1/4 of Section 35, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows:

Beginning at a point, which is the intersection of the Florth line of said Lot 71 and the Hast right of way line of Klomedale Road, as established by 1968 position which added 5 feet on each side of Romedale Road, from which the platted Florth vertical of said Lot 71 bears South 89 degrees 54' 35" West 5.00 feet, thence Rorth 20 degrees \$4' 35" East along the North line of said Lot 71, 241.21 feet to the tree point of beginning of this description, thence continuing North 39 degrees \$5' 35" East, 171.22 feet to a point; thence South 00 degrees 05' 25" East, 130.00 feet, thence South 42 degrees 21' \$4" West, 188.65 feet to a point; thence South 60 degrees 07' 41" Fast, 60.00 feet, to a point being on the south line of said Lot 71; feet to said East right of way line of Homedale Road; thence North 41 degrees 55' 52" East, 160.31 feet to a point; thence North 36 degrees 06' 27" East 149.95 feet, to a point; thence North 26 degrees 46' 16" East, 100.07 feet to the point of beginning, with bearings based on Preliminary Land Partition 10-92.
