THIS MATTER coming before the Klamath County Board of Commissioners upon petitioner, CU Building Corporation, petition filed previously herein in which said petition requested a vacation of the alley known as Fehlen Shopping Center Lots Alley, Section 34, Township 38 South, Range 9 East Willamette Meridian, Klamath County, Oregon.

It appearing that said petition contains all the information required by ORS 368.341(3) and that Earl Kessler, Klamath County Engineer, filed herein a written report containing assessment that the requested vacation of the above streets is in the public interest, said report referred under ORS 368.351(1), and

It further being determined that Warren Poole, Marian Poole, George Baker, Patsy Baker, Jack R.C. Hardin for the Credit Union Building, Harry Fredricks for Klamath County, Esther M. Zimmerman, Personal Representative of the Estate of Charles D. Davis, Terese Molly-Mae Seals, Susan Wagner, Raymond Nelson and Florence C. Nelson, whose acknowledged signatures are found on the Consent forms attached to the petition filed herein, constitutes 100% of the owners of land abutting the property proposed to be vacated,

2 IT IS FURTHER ORDERED that the following described real
3 property known as Fehlen Shopping Center Lots Alley be, and the
4 same hereby are, vacated, to-wit:

5 Alley to be vacated situated in "Fehlen Shopping Center
6 Lots", a duly recorded subdivision, being in the E $\frac{1}{2}$ SW $\frac{1}{2}$ SE $\frac{1}{2}$
7 of Section 34, T38S, R9EWM, Klamath County, Oregon, more
particularly described as follows:

8 Beginning at the initial point of said subdivision;
9 thence along the Easterly and Northerly boundaries of
said Subdivision, N01°48'E 342.9 Feet, N 39°36'W 538.85
10 and N 85°30'W 305.7 Feet to the Northwesterly corner of
said Subdivision; Thence S00°24'W 30.05 Feet to the
11 Northwesterly corner of Lot 1 of said Subdivision; Thence
along the Southerly and Westerly line of said alley,
12 S85°30'E 291.0 Feet and S39°36' E 529.0 Feet and S01°48'W
320.8 Feet to the South Line of Fehlen Shopping Center
13 Lots"; Thence S89°36' E 20.00 Feet to the point of
beginning.

14 Excepting therefrom: The Southerly 9.00 Feet lying
within the right-of-way of Shasta Way.

15 Subject to a reservation for Easements for existing utilities
16 that are presently located in the vacated alley.
