This matter having come before the Court on the verified
Petition for Appointment of Conservator and Guardian of Ruth
Mildred McEachern; and the Court having reviewed said Petition,
finds that Allen N. McEachern, the proposed protected person, is in
need of the appointment of a Temporary Guardian and Conservator;
that the proposed fiduciary, Ruth Mildred McEachern, is the wife of
the Ward, is competent to serve as the fiduciary in this matter,
and that due to the limited size of the proposed protected person's
estate, the requirement that the fiduciary post a bond should be
waived.

Based on the foregoing Findings, IT IS HEREBY ORDERED:

1. That Ruth Mildred McEachern is appointed as the Temporary
Guardian of the person of Allen N. McEachern and as the Conservator
of the protected person's estate;

2. That the filing of a bond by the Conservator is waived;

3. That the Administrator of the Court shall issue Letters of
Guardianship and Conservatorship to Ruth Mildred McEachern; and


