THIS MATTER coming before the court upon the Affidavit of Sandra Lee Pierce, petitioner herein; a Default Order having been granted and entered of record herein; it appearing that the court has jurisdiction of this matter; that the allegations of the petition are true in that irreconcilable differences between the parties have caused the irremediable breakdown of their marriage; that no children were born during the marriage and none are expected; petitioner has been a resident of Oregon continuously for six months prior to filing the Petition; the petitioner, having requested and the court finding that the respondent is in default, hereby waives the 90-day waiting period required by ORS 107.065(1) upon the grounds that the waiver of the waiting period will ease the emotional strain upon petitioner and the interest of the petitioner will thereby be served; now, therefore;

IT IS HEREBY DECREED, ORDERED, AND ADJUDGED as follows:

1. The marriage of the parties is hereby dissolved, effective on the 27 day of December, 1990;
