4. The consideration for this transfer is \$ 82,000.00

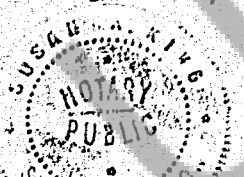

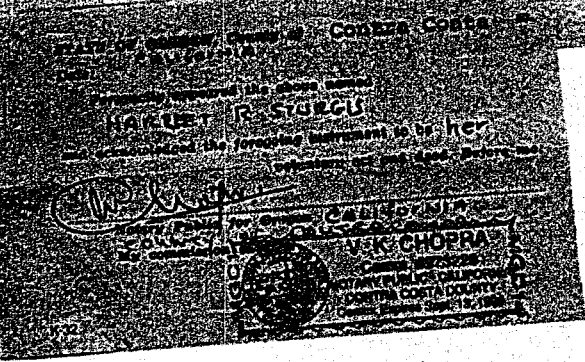
