### NATURE OF APPLICATION

A hearing on this application was held before the Planning Commission on September 22, 1992. The applicant is requesting a 17 lot re-subdivision of Washburn Park on 11.8 acres. This application was reviewed pursuant to Article 46 of the Klamath County Land Development Code. A quorum of the Planning Commission was present.

#### LOCATION

The 11.8 acres are located in a portion of Section 9 of Township 39, Range 9, tax lot 100.

#### RELEVANT FACTS

The applicant requested a re-subdivision of Lot 3 of Washburn Park on 11.8 acres. The zoning designation is CG(General Commercial). The zoning designation to the south of the site for development is also CG(General Commercial).

The minimum lot size of the General Commercial zone is 5000 square feet. The proposed lots are one third of an acre.

The subdivision has existing electricity, water and sewer services to meet the development standards of the Klamath County Land Development Code.

The subdivision is located in Fire District #1, with the fire station approximately two miles from the subdivision.

The access points to the subdivision are Edison Street and Onyx Street.
