EASEMENT

A strip of land six feet (6') in width, the southeasterly line being six (6) feet (6') southeasterly of and parallel with the northwesterly line of Lot 4 in Block 13, Supplementary Plat of Linkville, Klamath Falls, Oregon.

A strip of land five feet (5') in width, the northwesterly line being five feet (5') northwesterly of and parallel with the southeasterly lines of Lots 5 and 6 in Block 13, Supplementary Plat of Linkville, Klamath Falls, Oregon.

together with the right of ingress and egress over Grantor's adjoining lands for the purposes of this easement.

Grantor shall not erect any new structures, nor plant any trees or shrubs, within the easement area which would inhibit access to said sewer line or cause damage to it.

The Grantee, its successors or assigns, shall not be liable to Grantor for damage to the above-described premises occurring incidental to the proper use of this easement or to premises outside of and adjacent to the above-described parcel provided the party causing such damage shall repair same and place said premises in as good condition as they were immediately prior to such damage.

This document shall be binding upon all subsequent purchases or the above-described parcel, the Grantees, and the heirs, successors and assigns, of both.
