

ORDINANCE NO. 6639

AN ORDINANCE VACATING FOOTHILL BOULEVARD
BETWEEN THE EAST RIGHT-OF-WAY LINE OF DAGGETT AVENUE
AND APPROXIMATELY 1000 FEET EAST TO THE CITY LIMITS

WHEREAS, the owners of the real property hereinafter described, desire to vacate Foothill Boulevard between Daggett Avenue and the City Limits, approximately 1000 feet to the east; and

WHEREAS, after notice having been duly given, the City Planning Commission held a public hearing on May 18, 1992 on said request; and

WHEREAS, The City Council hearing notice having been duly given, did hold a hearing on July 6, 1992, on the record of the Planning Commission on the request of the property owner; and

WHEREAS, pursuant to such record and hearing, the City Council has determined the street vacation to be in compliance with the Community Development Ordinance and the Comprehensive Plan; NOW THEREFORE,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:


Foothill Boulevard located between Daggett Avenue and the City Limits, approximately 1000 feet to the east, in the McLoughlin Heights Subdivision, Map Number 3809-20AC, as shown on the official plat thereof on file in the office of the County Clerk for Klamath County, Oregon and according to the map attached hereto and incorporated as Exhibit "A", is hereby vacated; provided however, an easement for public utilities purposes is hereby reserved within the entire area to be vacated.

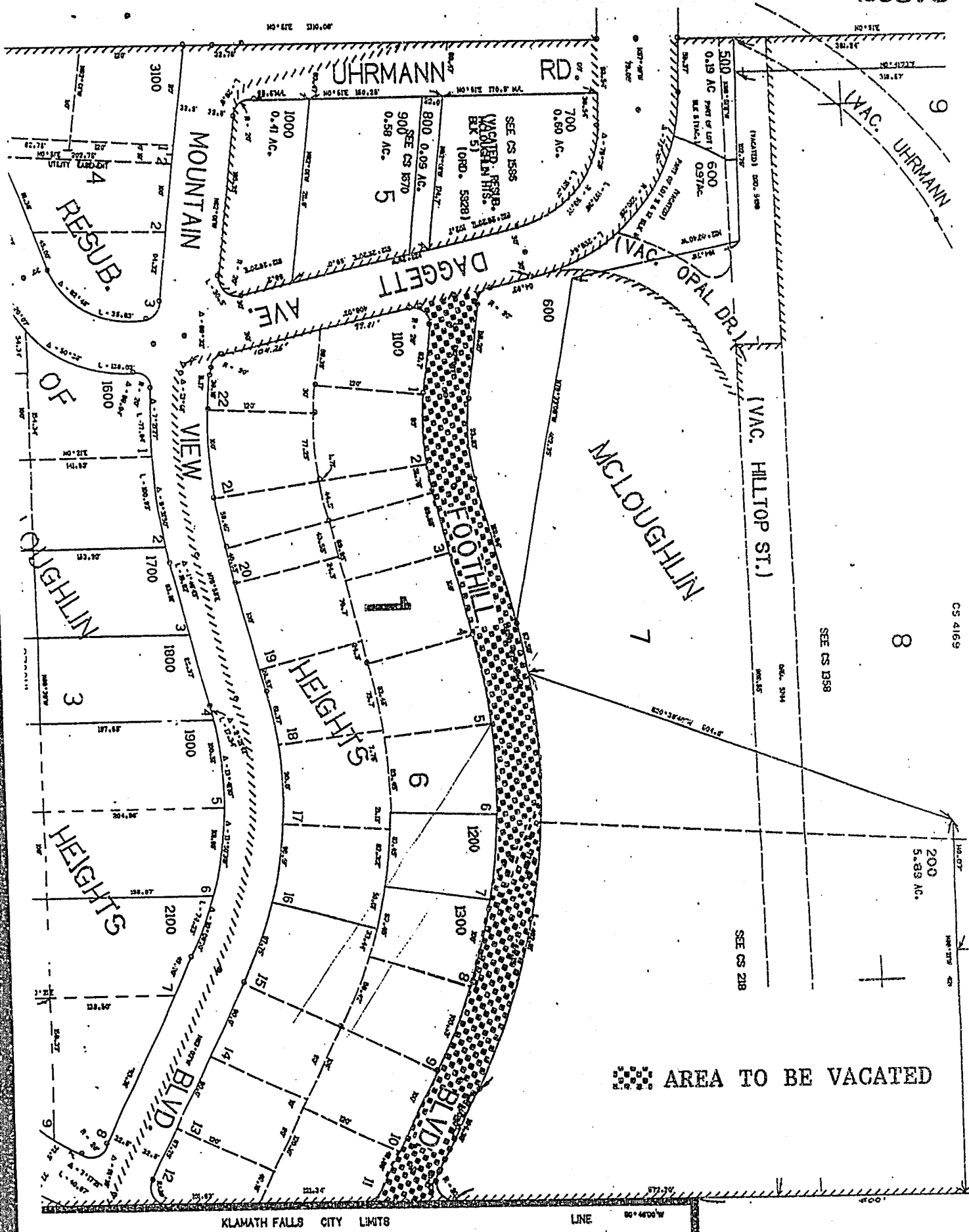
