AN ORDINANCE VACATING FOOTHILL BOULEVARD BETWEEN THE EAST RIGHT-OF-WAY LINE OF DAGGETT AVENUE AND APPROXIMATELY 1000 FEET EAST TO THE CITY LIMITS

Foothill Boulevard located between Daggett Avenue and the City Limits, approximately 1000 feet to the east, in the McLoughlin Heights Subdivision, Map Number 3809-20AC, as shown on the official plat thereof on file in the office of the County Clerk for Klamath County, Oregon and according to the map attached hereto and incorporated as Exhibit "A", is hereby vacated; <u>provided</u> however, an easement for public utilities purposes is hereby reserved within the entire area to be vacated.
