QUITCLAIM DEED

BURLINGTON NORTHERN RAILROAD COMPANY (formerly named Burlington Northern Inc.), a Delaware corporation, GRANTOR, releases and quitclaims, without any covenants of warranty whatsoever and without recourse to the Grantor, its successors and assigns, to OREGON DEPARTMENT OF TRANSPORTATION, a Oregon corporation, of 411 Transportation Building, Salem, Oregon 97310, GRANTEE, all right, title and interest in and to the real property situated in Klamath County, Oregon, described as follows:

A strip of land in the SE¼NE¼ of Section 18, Township 39 South, Range 9 East, Willamette Meridian, Klamath County, Oregon, being 100.0 feet in width, 50.0 feet on each side of the hereinafter described LINE "A", bounded on the Southeast side by a line drawn parallel with, distant 50.0 feet Northwesterly, as measured at right angles to the centerline of the Weyerhaeuser Lead Track and bounded on the Northwest side by the West Line of said SE¼NE¼.

LINE "A" DESCRIPTION

Commencing at the Southwest corner of the $SE\frac{1}{4}NE\frac{1}{4}$ of said Section 18; thence Easterly along the South line of said $SE\frac{1}{4}NE\frac{1}{4}$ of Section 18, a distance of 220.7 feet to a point on the centerline of the Weyerhaeuser Lead Track as now located and constructed; thence Northeasterly along said Lead Track centerline a distance of 176.4 feet; thence on an angle to the left from the last described course 43° 06' 30" to a point distant 50.0 feet as measured at right angles and radially to said Lead Track centerline for the Point of Beginning of LINE "A"; thence continuing Northeasterly along the last described course to a point on the West line of said $SE\frac{1}{4}NE\frac{1}{4}$ of Section 18 which point is distant 220.7 feet Southerly of the Northwest corner of the $SE\frac{1}{4}NE\frac{1}{4}$ of said Section 18, and there terminating; also,

A triangular parcel of land situated in the SE½NE½ and bounded on the Southwesterly side by a line drawn parallel with and distant 50.0 feet Northeasterly of above described LINE "A", and on the Southeasterly side by a line drawn parallel with and distant 50.0 feet Northwesterly of as measured at right angles and radially to said Weyerhaeuser Lead Track centerline, and on the Northeasterly side by the Southerly line of parcel conveyed by warranty deed dated November 17, 1950 to Klamath Door Company.

SUBJECT, however, to all existing interests, including but not limited to all reservations, rights-of-way and easements of record or otherwise.

EXCEPTING AND RESERVING, however, unto said Grantor, its successors and assigns, all of the coal, oil, gas, casinghead gas and all ores and minerals of every kind and nature, including sand and gravel, underlying the surface of the premises herein conveyed, together with the full right, privilege and license at any and all times to explore, or drill for and to protect, conserve, mine, take, remove and market any and all such products in any manner which will not damage structures on the surface of the premises herein conveyed, together with the right of access at all times to exercise said rights.
