PGT-PG&E PIPELINE EXPANSION PROJECT LAND USE AGREEMENT

The undersigned, hereinafter called first party (including its tenants, contractors or agents), in consideration of value paid by Pacific Gas Transmission Company, hereinafter called second party, the receipt of which is hereby acknowledged, hereby agrees to restrict use of first party's lands, as shown on drawing nos. 700-E-MA-1101, 700-E-MA-1102, and 700-E-MA-1103 attached as Exhibits A, B and C, located within and/or adjacent to the pipeline transmission easement recorded in the official records of Klamath County, State of Oregon, Book 324, Page 295.

First party shall be restricted from using the subject area for grazing any type of domestic animals, farming operations, or vehicular traffic. Further, the first party shall not plow, disk, apply pesticides or chemicals, perform controlled burning, alter drainage patterns or in any other manner disturb or modify the soil. The first party shall not erect or construct any building or other structure or drill or operate any well, or construct any reservoir or other obstruction on said area.

First party acknowledges second party has an easement for the construction, operation, and maintenance of a pipeline within the area described in the above-referenced pipeline transmission easement, and a right of ingress to and egress from said easement, including the right to restore the easement area and monitor the restoration. for one year and thoughter not to exceed:

This agreement will remain in effect from extended by mutual agreement of both parties.

Second party agrees to pay, in addition to the above stated consideration, any damages to growing crops, fences, buildings and other improvements, roads and timber which may immediately and directly result from this agreement.

First party shall take ordinary care in protecting the above described area. First party will be liable for any and all damages resulting from its negligence.






