WHEREAS, the Circuit Court for the State of Oregon for Klamath County, did on the 15th day of February, 1985, make and enter a decree of foreclosure in favor of the State of Oregon, represented and acting by the Director of Oregon Department of Veterans' Affairs, against David Wayne Castor; Jeri-Lynn Castor; Pacificorp, dba Pacific Power and Light Company; Mellon Financial Services Corporation; United States of America, Internal Revenue Service; and Oregon Department of Revenue, foreclosing them of all their right, title, estate, lien or interest in or to the premises hereinafter described or any portion thereof, on which decree a writ of execution in foreclosure was issued, dated the 17th day of April, 1985, directed to the Sheriff of said county to execute; and by virtue of said execution in foreclosure the lands hereinafter described were struck off and sold to the State of Oregon, represented and acting by the Director of Oregon Department of Veterans' Affairs, it being the highest and best bidder therefore, on the 23rd day of May, 1985, and the time and place thereof having been duly advertised according to law. 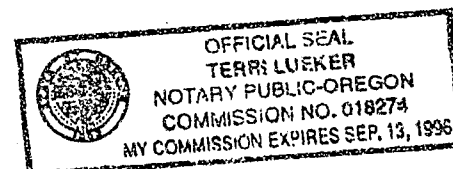
