RECITALS:

A. On November 1, 1978 the Vendor and Purchaser entered into a Contract of Sale concerning certain real property situated in Section 33 of Township 39 South, Range 9 East of the Willamette Meridian of Klamath County, Oregon, which is fully described in said Contract of Sale and the Memorandum of Contract for Deed dated November 1, 1978 and recorded in Volume M78, page 29042, Records of Klamath County, Oregon, for a purchase price of \$92,500, of which \$15,000 was paid as a down payment, and the deferred balance of \$77,500 in 15 annual payments of \$5,170.00, plus interest at $8\frac{1}{2}$ percent per annum.

B. The Vendor made specific provisions which would penalize the Purchaser for prepayment and the Vendor has preferred that the Contract of Sale payments be deferred so as to not create an undue tax burden to the Vendor.

C. There is now due and owing the balance of \$49,245.50 on the Contract of Sale, with interest accruing at $8\frac{1}{2}$ percent from December 28, 1991.

D. The Purchaser desires to sell the real property subject to the Contract of Sale to a third party.

E. In an effort to develop a uniform system of payments to liquidate the indebtedness in a manner that is advantageous to both the Vendor and Purchaser, the parties hereto enter into this

MODIFICATION AGREEMENT

1. The Purchaser will pay to the Vendor the sum of \$12,000.00, including interest, prior to December 31, 1992.

2. The Purchaser will pay to the Vendor 1/10th of the remaining principal balance, plus accrued interest, on or before December 31 of each year, with the first payment to be due and payable on or before December 31, 1993, until the entire remaining

Purchaser retains the right to pay principal payments during any three calendar years in an amount not to exceed that amount which equals two principal payments without penalty.

3. The prepayment penalties set forth in the Contract of Sale dated November 1, 1978 shall remain in effect during the period of reamortization set forth in Section 1 of this Modification Agreement.

4. The Vendor consents to the sale of the property subject to the terms and provisions of the Contract of Sale dated November 1, 1978.

5. All other terms of the Contract of Sale dated November 1, 1978 not specifically modified by this Modification Agreement shall remain in effect.
