KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated November 8, 1990, executed and delivered by R. Mark Trelease as grantor and recorded on November 15, 1990, in the Mortgage Records of Klamath County, Oregon, in book/reel/volume No. M90 at page 22798, and/or as fee/file/instrument/microfilm/reception No. (indicate which), conveying real property situated in that county described as follows:

A parcel of land situated in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 10, Township 39 South Range 9, E. W. M., described as follows:
