AN ORDINANCE VACATING CERTAIN STREETS  
LYING IN BLOCKS 140, 141, 143, 145, 146, 148,  
149, 150 AND 151, BUENA VISTA ADDITION  
TO THE CITY OF KLAMATH FALLS

WHEREAS, The City Planning Commission, pursuant to a public hearing on March 14, 1988, did recommend the City Council grant the proposed vacation; and

WHEREAS, on April 18, 1988, the City Council held a public hearing on a proposal to vacate certain streets lying in Blocks 140, 141, 143, 145, 148, 149, 150, and 151, Buena Vista Addition to the City of Klamath Falls; and

WHEREAS, The City Council has determined that it is in the best interest of the City of Klamath Falls that said streets be vacated;  
NOW, THEREFORE,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

Subject to the reservation in Section 2, that dedicated streets and alleyways lying in between Blocks 140, 141, 143, 145, 146, 148, 149, 150, and 151, Buena Vista Addition to the City of Klamath Falls as shown on the official plat thereof on file in the office of the County Clerk for Klamath County, Oregon, and as shown on to the map attached hereto and incorporated herein as Exhibit "A", are hereby vacated.

Section 2.

There is hereby reserved a utility easement sixteen (16) feet wide, over, under and across that portion of Block 151, Buena Vista Addition that is vacated by this ordinance. The easement is for the purpose of constructing, operating, maintaining, relocating, removing, and/or replacing utility lines and necessary or desirable appurtenance thereto, and is described as follows:

A strip of land sixteen (16) feet wide, lying eight (8) feet on each side of the centerline of the alley in Block 151 of Buena Vista Addition to the City of Klamath Falls, Oregon; said strip of land beginning at the west line of said Block 151 and running east to the westerly right of way line of Stanford Street.

Passed by the City Council of the City of Klamath Falls, Oregon, this 2nd day of May, 1988.



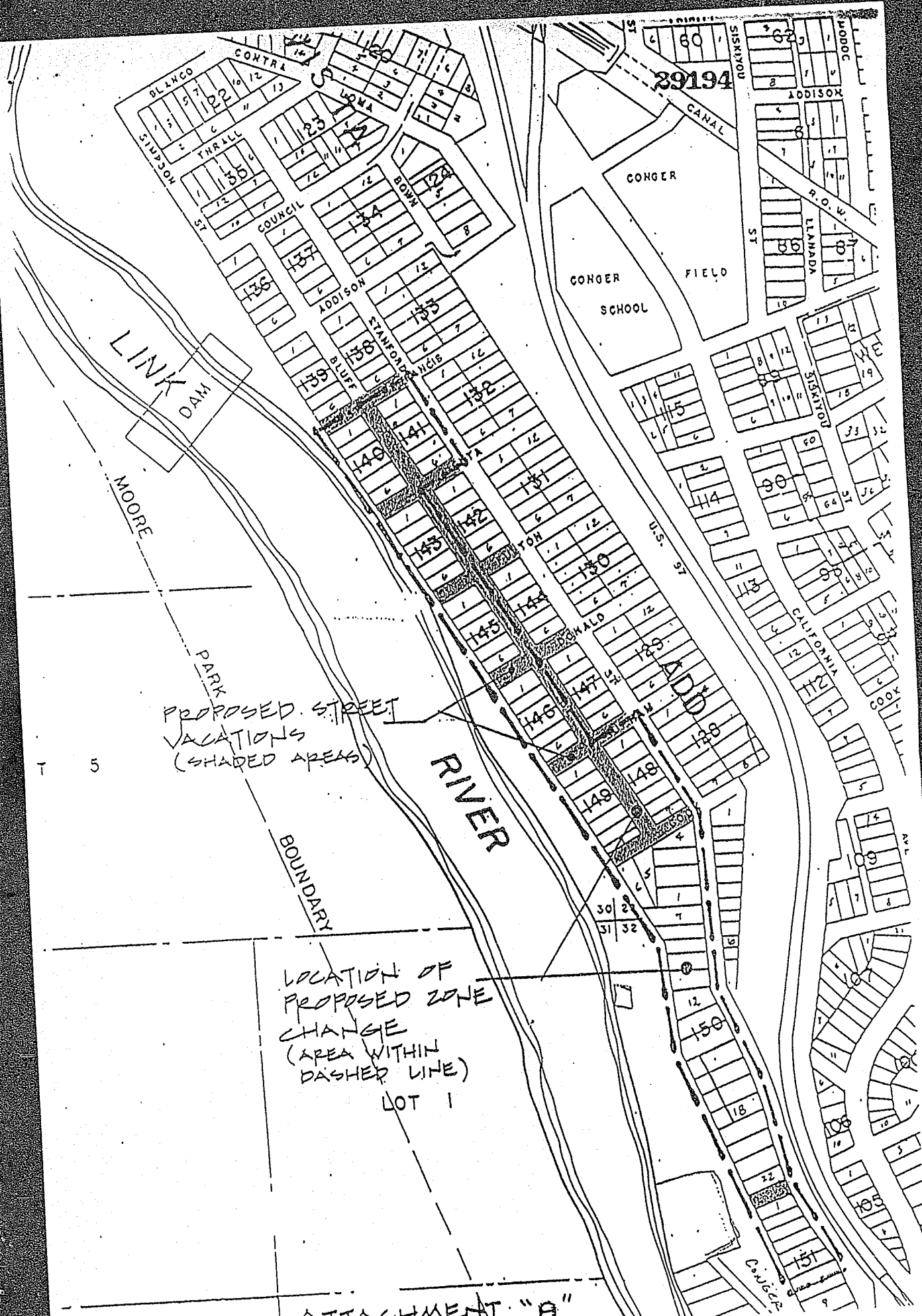
