\_\_\_\_\_ Dollars (\$ \_\_\_\_\_) and other good and valuable consideration, the receipt whereof is hereby acknowledged, do hereby grant and convey to U S WEST Communications, Inc., a Colorado Corporation, (Grantee) whose address is 1600 7th Ave., Seattle, Washington 98191 its successors, assigns, lessees, licensees and agents a perpetual easement to construct, reconstruct, operate, maintain and remove such telecommunications facilities as Grantee may require upon, over, under and across the following described land which the Grantor owns or in which the Grantor has any interest, to wit:

The Western portion of a parcel called 2B (See R.O.S. #1010), Township 39 South, Range 10 East, W.M., Section 9C, known as Tax Lot 801, Klamath County, Oregon.

The easement is as follows: A strip of land 10 (ten) feet in width and 350 (three hundred fifty) feet in length, within that certain private roadway known as a private roadway, as placed, and being a portion of the above described property.

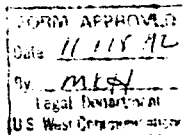
The Grantor reserves the right to occupy, use and cultivate said Easement for all purposes not inconsistent with, nor interfering with the rights herein granted.
