6 That the Petition is granted and that the portion of Mesa
7 Street and lots 116, 117, 118, 119 and 120 Odessa Summer Home Sites
8 as described on Exhibit A is hereby vacated, as said vacation is in
9 the public interest. It is further ordered that pursuant to ORS
10 365.366(1)(d), the vacated street is vested in the owners of the
11 abutting property by extension of their property boundaries to the
12 center of the vacated street.


13 IT IS FURTHER ORDERED:

16 for payment of the costs are the Petitioners.


