The true and actual consideration for this transfer is cancellation of the debt in the above-described Contract for Sale of Real Property.

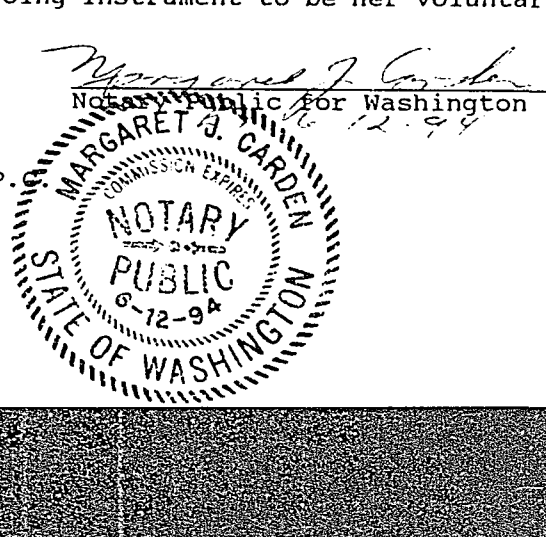
