1. DESCRIPTION OF CONTRACT:

(A) PURCHASER: Michel Vega - transferred by quitclaim deed to Albert Mena, Jr. 11-14-85, recorded 12-9-85, Vol. M85, page 20012, deed records of Klamath County, Oregon

(B) SELLER: THE BANK OF CALIFORNIA, N.A., as Trustee

(C) CONTRACT RECORDED: 3-30-83, vol. M83, Page 4691, Deed of records of Klamath County, dated 2-10-83

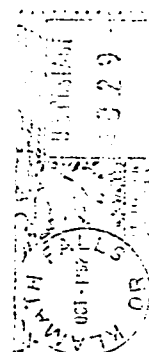

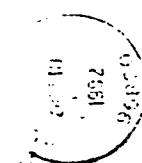
