## **RECITALS:**

A. Venable is a partner in the partnership of Biaggi-Venable under an agreement dated January 21, 1977.

- B. Venable has secured the approval of the remaining members of the partnership to the sale of a portion of his partnership interest to each of Matthew and Kimberly.
- C. Each of Matthew and Kimberly has agreed to purchase forty-eight percent of Venable's interest.

## AGREEMENT:

The parties agree:

1. Transfer of Interest. Venable hereby transfers forty-eight (48%) percent of his said partnership interest in Biaggi-Venable to Matthew and forty-eight (48%) percent of his said partnership interest to Kimberly. The purchase price is \$46,793.77 to be paid in monthly installments of \$451.57 including interest at the rate of ten (10%) percent per year by the promissory notes of each of Matthew and Kimberly copies of which are attached to this agreement as Exhibits A and B respectively and incorporated by this reference. These transfers constitute Matthew owner of a twelve percent interest and Kimberly owner of a twelve percent interest in the Biaggi-Venable Partnership.
