KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated November 29, 1978, executed and delivered by LOWELL R. 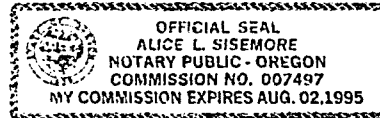
