Lots 18 and 19 in Block 9 of WEST CHILOQUIN, Township 34, Range 7.0, Section 34, according to the duly recorded plat thereof on file in Klamath County, Oregon, containing 12,000 square feet, more or less.

This conveyance is subject to all valid existing rights, including liens and outstanding taxes. This conveyance is authorized by 25 U.S.C. 566d, the Klamath Restoration Act.

The true consideration for this conveyance is none for the conversion of fee title to trust.

This instrument will not allow use of the property described in this instrument in violation of applicable land use laws and regulations.
