Lot 3 in Block 4 of LaWanda Hills, according to the official plat thereof on file in the office of the County Clerk of Klamath county, Oregon.

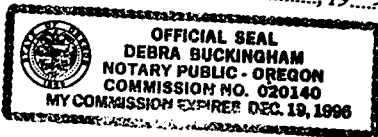
