WHEREAS, on the 25th day of January, 1993 S. Scott Miller and Genie Miller conveyed to Klamath County, Oregon certain property for County Road purposes, described as follows:

A parcel of land for road purposes situated in the NE1/4 of Section 26, T.38S., R.11 1/2E., W.M., Klamath County, Oregon, being a portion of that property described as Parcel 2 of Exhibit "A", in Deed Volume M90 Page 20531, Klamath County deed records and more particularly described as follows:

Beginning at a 5/8" iron pin on the West right-of-way of Bliss Road, said point being S00 degrees 10'01"E., 1553.00 feet from a 5/8" iron pin which marks the Northeast Corner of that parcel of land shown on Survey No. 17 filed in the Klamath County Surveyor's Office and also being the Northeast Corner of said Parcel 2; thence N00 degrees 08'29"W., 50.00 feet along the West right-of-way of Bliss Road to a 5/8" iron pin; thence S89 degrees 51'31"W., 10.00 feet to a 5/8" iron pin; thence S00 degrees 08'29"E., 48.54 feet to a 5/8" iron pin; thence S81 degrees 50'00"E., 10.11 feet to the point of beginning. Said parcel contains 0.011 acres. Bearings and distances are based on Survey No. 5323 filed in the Klamath County Surveyor's Office.

WHEREAS, the Board of County Commissioners of Klamath County, Oregon sitting in regular session deemed it to be in the best interests of said County to accept the herein described property for County Road purposes;


IT IS THEREFORE RESOLVED that the property conveyed to Klamath County, Oregon by S. Scott Miller and Genie Miller on the 25th day of January, 1993 shall be accepted as County Road right-of-way for BLISS ROAD.




