NUISANCE ABATEMENT LIEN ORDER

TO: COUNTY CLERK OF KLAMATH COUNTY

WHEREAS, on April 15, 1992, a Default Declaratory Judgment and Decree was entered against Richard E. Hough and Julianne Hough in favor of Plaintiff Klamath County issuing a Decree of Abatement and finding Defendants in violation of Chapter 401 (formerly Chapter 110) of the Klamath County Code for having a dangerous building on the above property which was declared a public nuisance, and a fire and safety hazard to the general public.

WHEREAS, Plaintiff Klamath County had the dangerous building demolished by Bob's Excavating, 5800 Airway Drive, Klamath Falls, Oregon 97603 on October 16, 1992. The cost of the abatement was \$1,600.00 plus an administrative charge of \$400.00 in accordance with Klamath County Code 401.200 (formerly 110.200) for a total cost of \$2,000.00.

WHEREAS, on October 27, 1992, Plaintiff sent a NOTICE OF DEMAND to each of the Defendants by both Certified Mail, Return Receipt Requested, and regular mail demanding payment of \$2,000.00 within thirty days of the date of the Notice of Demand. All Notices were returned to Plaintiff "unclaimed".

WHEREAS, Defendants have failed to pay said sum.
