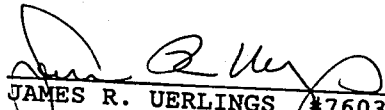

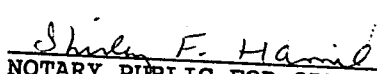

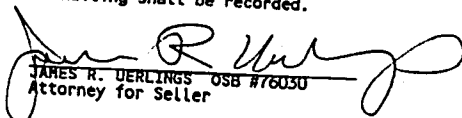

1. DESCRIPTION OF CONTRACT:

 - (B) SELLER: THE BANK OF CALIFORNIA, N.A., as Trustee
 - (C) CONTRACT RECORDED: 12-2-82, vol. M82, Page 16686, Deed of records of Klamath County, dated 6-6-81
 - (D) AMOUNT AND TERMS OF CONTRACT: \$6,000.00. \$300.00 down, balance of \$5,700.00 at \$88.51 per month starting 8-15-81 until paid including 14% interest per annum.

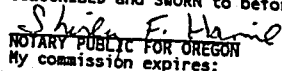
