situated in County of Klamath State of Oregon

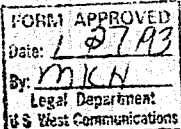

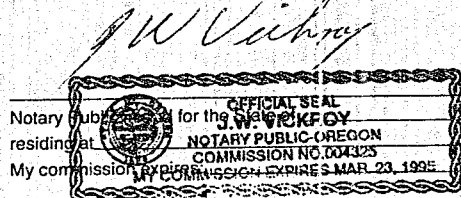
