Dollars (\$ ) and other good and valuable consideration, the receipt whereof is hereby acknowledged, do hereby grant and convey to U S WEST Communications, Inc., a Colorado Corporation, (Grantee) whose address is 1600 7th Ave., Seattle, Washington 98191 its successors, assigns, lessees, licensees and agents a perpetual easement to construct, reconstruct, operate, maintain and remove such telecommunications facilities as Grantee may require upon, over, under and across the following described land which the Grantor owns or in which the Grantor has any interest, to wit:

The  $W\frac{1}{2}$  of the  $NW\frac{1}{4}$  of the  $NW\frac{1}{4}$  of the  $SW\frac{1}{4}$  of Section 25, Township 24 South, Range 8 East, W.M., Tax Lot 1700, Klamath County, Oregon.

The easement is as follows: A strip of land 10 (ten) feet in width and 20 (twenty) feet in length, within that certain private roadway known as Friendly Acres, as placed, and being a portion of the above described property.
