PARCEL 1

A portion of land in the Northeast quarter of the Northeast quarter of Section 1. Township 40 South, Range 7 East of the Willamette Meridian, more particularly described as follows:

Beginning at $\frac{1}{2}$ " iron pin which lays North 89°31' West a distance of 567.4 feet from the Northeast corner of said Section 1, said point being on the North line of said Section 1; thence continuing on said Section line North 89°31' West a distance of 407.4 feet to a $\frac{1}{2}$ " pin; thence South 0°11' West a distance of 395.0 feet to a $\frac{1}{2}$ " iron pin which is on the Northerly right of way line of State Highway; thence Northeasterly along said right of way following a curve to the right 449.6 feet to a $\frac{1}{2}$ " iron pin. Said curve having a radius of 1200 feet and whose long chord lays North 66°26' East and a length of 446.0 feet; thence North 213.0 feet, more or less, to the point of beginning.
