KNOW ALL MEN BY THESE PRESENTS, That JUDY K. COCKRELL, hereinafter called the grantor,

for the consideration hereinafter stated to the grantor paid by JUDY K. COCKRELL AND CALEB EDWARD HOLLAND

hereinafter called grantees, hereby grants, bargains, sells and conveys unto the said grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of said grantees, all of the following described real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of Klamath, State of Oregon, to-wit:

Lots 22, 23 and 24 Modoc Point, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

And the grantor above named hereby covenants to and with the above named grantees, their heirs and assigns, that grantor is lawfully seized in fee simple of said premises, that same are free from all encumbrances

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

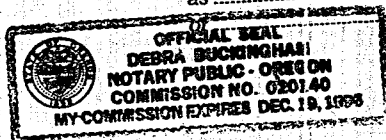
In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.
