11 Petitioner for a Order of Default, and Respondent not having

14 The Court makes the following Finding of Fact:

15 1. Petitioner BARBARA LOUISE MCCOLLUM'S monthly gross income

18 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED as follows:

(3) day notice to Petitioner BARBARA LOUISE MCCOLLUM. The parties are encouraged to work together for the benefit of the children and to nurture the relationship of the other parent with the children.

3. Respondent CRAIG LEROY ANDRESEN is ordered to pay and Petitioner BARBARA LOUISE MCCOLLUM shall have judgment against Respondent in the sum of \$150 per month per child for a total of \$450 per month as Respondent's contribution toward the support of the minor children of the parties, namely, NICOLE MARIE ANDRESEN, born July 19, 1983, AMANDA KAY ANDRESEN, born January 11, 1986, and JESSIE RAY ANDRESEN, born August 31, 1987, which support shall be paid on the first day of each month hereafter until each child reaches the age of 18 years or becomes otherwise emancipated, but which shall continue until each child reaches the age of 21 provided the child is a child attending school within the definitions of ORS 107.108 (4), and which support shall be paid through the Department of Human Resources, P.O. Box 14506, Salem, OR 97310.

#### NOTICE OF INCOME WITHHOLDING

The support order is enforceable by income withholding under Section 4 of the Act. Withholding may occur whenever there are arrearages at least equal to the support payment for one month or whenever the obligated parent requests such withholding. The District attorney or as appropriate the Support Enforcement Division of the Department of Justice will assist you in securing such withholding.

As additional child support, Respondent is ordered to maintain medical and dental insurance on the minor children of the parties provided such insurance is available to him at no additional cost through his place of employment.

4. Petitioner BARBARA LOUISE MCCOLLUM is hereby awarded as her sole and separate property free from any claim by Respondent the lots and the mobil home located in Klamath County, Oregon, described more particularly as follows:

If the documents are not executed within that time period, this Order and Judgment shall be effective to transfer title to both the real and personal property described herein.

6. Each party is awarded the personal property in his or her possession.

7. Each party is ordered to pay and hold the other party harmless from the debts incurred by him or her after the date of separation, January, 1987.

8. Respondent is hereby ordered to pay and Petitioner BARBARA LOUISE MCCOLLUM is hereby awarded judgment against Respondent in the sum of \$500 representing Petitioner's reasonable attorney fees incurred herein.
