hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath , State of Oregon, described as follows, to-wit:

Lot 2 in Block 2 of Replat of Bureker Place, according to the offical plat thereof on file in the office of the County Clerk of Klamath County, Oregon, LESS the following described portion conveyed to George L. Stevens and Elfie Stevens, husband and wife, by Deed recorded in Book 221 page 445, Records of Klamath County, Oregon as follows:
