Government Lots 12, 13, 19, 20, 21 and 22, Section 33, Township 35 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon.

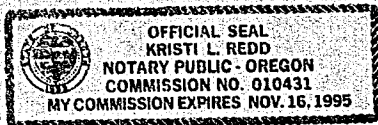
