KNOW ALL MEN BY THESE PRESENTS, That Ann Battin, only heir of Bula H. Kelsey

for the consideration hereinafter stated, does hereby remise, release and quitclaim unto Lee R. Wright and Diana L. Wright, husband and wife, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Beginning at a point on the Southerly line of Summers Park which lies West a distance of 245 feet from a point on the East line of E1/2 SE1/4 of Section 10, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, which last mentioned point is 163.75 feet North of the Northeast corner of property conveyed to A. N. Kelsey and Bula H. Kelsey by deed recorded May 9, 1944 in Volume 164 at page 552, Klamath County Deed Records, and running from said point of beginning West along said Southerly line of Summers Park a distance of 20 feet to a Northeast corner of property conveyed by grantor to grantees by deed recorded September 20, 1955 in Volume 278 at page 36 of Klamath County Deed Records; thence Southerly along the third course described in said deed from grantor to grantees a distance of 103.75 feet, more or less, to the Westerly terminus of the line which is the second course described in said deed from grantor to said grantees; thence East along said last described line a distance of 20 feet to a point; thence North a distance of 103.75 feet, more or less, to the point of beginning.

The property herein granted is the Westerly rectangular 20 feet of property of grantor remaining after the conveyance to grantee by said deed recorded in Volume 278 at page 36 of Klamath County Deed Records.

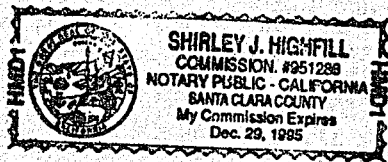
