 word "beneficiary" includes any successor in interest to the beneficiary named in said trust deed.

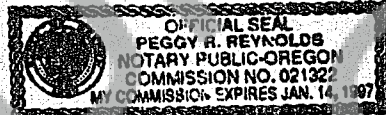
