RECITALS:

A. JAMES W. HAYES and ROBERTA M. HAYES, Grantor, executed and delivered to ASPEN TITLE & ESCROW, INC., Trustee for the benefit of TOWN & COUNTRY MORTGAGE, INC., Beneficiary, a Trust Deed dated March 7, 1985 and recorded on March 14, 1985, in the Official Records of Klamath County, Oregon as Volume M85, Page 3778 (the Trust Deed). In the Trust Deed, the following described real property (the Real Property) was conveyed by the Grantor to the Trustee to secure the performance of certain obligations to the Beneficiary:

Lot 1 in Block 8, BUENA VISTA ADDITION to the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, in the County of Klamath, State of Oregon.

Thereafter the Grantor defaulted in performance of the obligations secured by the The default still existed at the time of sale by the Trustee to the Trust Deed. Grantee.

B. MICHAEL C. AROLA was appointed Successor Trustee of the Trust Deed. The appointment was recorded on Augusts 17, 1992 in the Official Records of Klamath County, Oregon as Volume M92, Page 18316.

C. The Beneficiary declared the Grantor of the Trust Deed to be in default. The reasons for the declaration of default, the Beneficiary's election to declare all sums due to it immediately due and the Beneficiary's election to foreclose the Trust Deed by advertisement and sale to satisfy the Grantor's obligations was recorded on August 17, 1992 in the Official Records of Klamath County, Oregon as Volume M92, Page 18317.

D. After recording the Notice of Default and Election to Sell, the Trustee gave notice of the time and place set for sale of the Real Property. Notice of the sale was given:

1. To all persons entitled to receive such notice by mailing the notice to them at their last known addresses by both first class mail and certified mail, return receipt requested. The notice was mailed to them more than 120 days before the Trustee conducted the sale. An Affidavit of Mailing of such notice was recorded in the Official Records of Klamath County, Oregon as Volume M92, Page 29096, prior to the day the Trustee conducted the sale. An Amended Trustee's Notice of Sale After Relief From Stay was mailed to all persons entitled to receive such notice more than 20 days before the Trustee conducted the sale. An Affidavit of Mailing of such notice was recorded as Volume M93, Page 9364.

2. To the occupants of the Real Property by personal service, more than 120 days prior to the day the Trustes conducted the sale. A Proof of Service was recorded in the Official records of Klamath County, Oregon as Volume M92, Page 29096, prior to the day the Trustee conducted the sale.

3. By publishing such notice in the <u>Herald and News</u>, a newspaper of general circulation in Klamath County, Oregon, once a week for four successive weeks. The last

E. On the date of the Notice of Sale, the Trustee did not have actual notice of any person claiming an interest which was subsequent to the Trustee's interest in the Real Property, except for those persons named in the affidavits referred to in Recital D. of this deed.

F. On May 20, 1993, at 10:00 a.m. at the front of the Klamath County Courthouse, 316 Main Street, Klamath Falls, Oregon, the Trustee sold the Real Property in one parcel at public auction to the highest bidder for cash. The price bid was paid at the time of sale.

G. At no time during the period of time between the recording of the Notice of Default and Election to Sell and the date of the sale, was the real property described in and covered by the Trust Deed, or any interest therein owned by a person in the military service of the United States of America, a minor or an incapacitated person.

H. The true and actual consideration paid for this transfer is \$44,637.00.

I. In construing this instrument, whenever the context requires, the following shall apply:

1. References to a specific gender shall include the masculine, feminine and neuter genders.

2. Reference to the singular shall include the plural and vice versa.

3. References to the Trustee shall include any Successor Trustee.
