PERMANENT DRAINAGE EASEMENT

SHORT TRUST DATED DECEMBER 10, 1991, Grantee, and unto Grantee's heirs, successors and assigns forever a permanent drainage easement over and across that property described in Deed Volume M92 Page 19765 recorded in the Klamath County Clerk's Office; said easement to be 30 feet wide and being more particularly as follows:
